Course Objectives:

The **boundary layer** is the part of the atmosphere that is affected by interactions with the surface. This course covers the fundamentals (processes, spatial and temporal variations and methods for measuring and modeling) of atmosphere-surface interactions, including:

(1) radiation fluxes,

- (2) turbulent heat, moisture, and momentum fluxes, and
- (3) subsurface conductive fluxes.

The boundary layer is where humans, animals and plants live. Therefore, it is an important part of the atmosphere and it has a direct impact on the biosphere. Human activities both control, and are controlled by, boundary layer climates. For example, atmospheric pollutants are concentrated near the surface and diffuse into the atmosphere by turbulence. Land use/land cover regulates the daily and seasonal cycles of energy and moisture exchange between the surface and the atmosphere. Large-scale atmospheric motions are influenced by surface energy exchanges.

Students will gain the conceptual framework necessary to understand and quantify surfaceatmosphere interactions. The course will also explore the various ways that anthropogenic activities influence these interactions (especially at local to regional scales).

The lectures will provide the theoretical background for the class. The homework assignments will give students the opportunity to apply these principles. The research paper will provide the students with an opportunity to explore in greater depth a topic that is of interest to them.

Learning Objectives:

As a result of taking this course you should know certain things (knowledge objectives) and be able to do certain things (skill objectives).

- Evaluate how human activities are influenced by moisture and energy fluxes in the boundary layer at local, regional and global scales [Goal A: 1e]
- Critically evaluate and identify sources of uncertainty measurements and models of surface energy and water exchanges [Goal B: 3b]

Skill objectives (Things you should be able to do by the end of the course):

- Calculate and interpret a surface energy budget [Goal B: 3h]
- Calculate and interpret a surface water budget [Goal B: 3h]
- Quantify the influence of atmospheric stability on energy, moisture and momentum fluxes [Goal B: 3f]
- Summarize the main findings and evaluate the strengths and weaknesses of journal articles [Goal C: 1c and 1f]
- Use python to generate graph and visualize data [Goal B: 3a]
- Generate graphs and maps for your research paper and oral presentation [Goal C: 1g]
- Critically evaluate the published research and the research of your peers [Goal D: 1a and 1b]
- Write a scientific research paper or literature review paper that develops an argument from multiple sources. This paper will conform to the standard for publication in a peer-reviewed journal [Goal C: 1i]
- Deliver a clear and concise oral presentation on the research that you completed during the semester [Goal C: 1d]

Exercises (30% each)

The exercises will require you to apply what you learn in this class. There will be 8 exercises assigned during the semester. The exercises will be assigned one week before they are due. These are <u>individual</u> assignments and each student must submit their own work. However, you may discuss the questions and work collaboratively. **There are no makeup assignments and late submissions are not accepted.**

Exams (20% each)

The two exams will be based on the material covered in the lectures, readings, and exercises. The

final exam will be cumulative. They will involve short answer, application and problem solving (based on the exercises), and paragraph/essay questions.

- Midterm Exam (Thursday, March 11)
- **Final exam** (Thursday, April 29, 10:00-11:45 am) will be cumulative. The final exam will be an open book, take home exam. It will be a timed exam. You will be provided with the questions at 10 am on April 29 and you will have to return it by noon.

Barring extraordinary circumstances, there will be no make-up exams. Written documentation will be required and verified before a make-up exam will be considered. Students must contact the instructor **prior** to any exam to be considered for a make-up exam.

Research Paper (20%)

The research paper will provide you with an opportunity to do an in-depth study on a topic related to boundary layer climates that is of interest to you. I am expecting you to either provide a review and synthesis of the relevant literature and/or to analyze data. The paper should be approximately 12 to 14 pages of text and should follow the style of *Journal of Applied Meteorology and Climatology*. The research paper is due on Monday, April 19 (worth 20% of your final grade).

You are welcome to select any topic that relates to boundary layer climates. I have listed examples of a number of topics that would be appropriate:

- How does land use/land cover change influence the local and regional climate? It would be best to select a specific type of land cover change such as urbanization, deforestation, irrigated agriculture, etc.
- Urban heat islands or urban climates
- Air pollution
- Impact of aerosols on clouds, hurricanes, or ...
- Select one component of surface-atmosphere interactions (ocean-atmosphere, landatmosphere; sea ice-atmosphere) and examine how it will be influenced by climate change (or by other anthropogenic activities)
- How do land-atmosphere interactions influence/cause droughts?
- Impact of the land surface on hurricanes (i.e., brown ocean)

Oral Presentation (5%)

Each student will present a 6 to 8-minute summary of their research paper in class on either April 20 or 22 (worth 5% of your final grade). I will distribute a grading rubric and discuss the requirements of the presentation in class.

Article Reviews (5%)

The second half of the course (after midterm exam) will focus on reading and discussing journal articles. You are expected to carefully and critically read all of the assigned journal articles. Before each class you are expected to read the assigned material and submit your written response to the discussion on Carmen. Your reviews will be graded.
