Course description

This course examines the spatial and system-wide aspects of transportation in the U.S. and internationally. It covers transportation methods at the introductory level and emphasizes the applications and critical views of the transportation system.

Course learning outcomes

Upon successful completion of this course, students should be able to:

- Summarize key theories underlying the spatial organization and operations of transportation systems.
- Analyze interconnections within and between social, environmental, and transportation systems.
- Interpret patterns in transportation systems.
- Apply concepts and methods to solve real-world problems in transportation.
- Identify strengths and weaknesses of theories and methods.
- Identify consequences of development processes and affected parties.
- Recognize and value differences in interests of stakeholders.

Evaluate the outcomes and performance of a transportation system.

HOW THIS ONLINE COURSE WORKS

Mode of delivery: This class is *hybrid* with online lectures and in-class discussions and reviews. All video lectures and learning materials will be uploaded on Carmen Canvas. The in-class discussion will not be recorded due to the lack of supporting technologies in the classroom (e.g., microphone for the entire class).

Pace of online activities: This course is divided into **weekly modules** that are released in advance. Students are expected to keep pace with weekly deadlines but may schedule their efforts freely within that time frame.

Credit hours and work expectations: This is a **3-credit-hour course**. According to Ohio State policy (go.osu.edu/credithours), students should expect around 3 hours per week of time spent on direct instruction (instructor content, group and Carmen activities, for example) in addition to 6 hours of homework (reading and assignment preparation, for example) to receive a grade of (C) average.

Attendance and participation requirements: Your attendance is based on your online activity and participation. The following is a summary of students' expected participation:

- Participating in online activities for attendance: AT LEAST ONCE PER WEEK
 You are expected to log in to the course in Carmen every week to watch the online lectures and
 check out the reading assignments.
- Participating in in-class sessions: ONCE PER WEEK
 You will come to class once a week on the day that you are assigned (i.e., Tuesdays or
 Thursdays). By default, if are assigned to the Tuesday sessions if your last name starts with
 letter A through L, and Thursday otherwise. For example, if your last name is Smith (which
 starts with S), you will attend the in-person sessions on Thu.
 - If you have a situation that might cause you to miss an entire week of class, discuss it with us as soon as possible.
- Office hours: RECOMMENDED
 All live, scheduled events for the course, including our office hours, are recommended.

Communications with instructor and TA outside of classroom: Questions related to class materials and assignments should be posted on Carmen discussion board under the thread created for that particular week. We will check these posts once per school day. We encourage you to help your classmates out if you know the answers, but make sure you are not violating the code of student conduct (e.g., do not upload your assignment or show them the exact answer to complete their assignments).

Descriptions of major course assignments

Description: In each assignment, you will create a short memo for transportation practitioners to support them in the decision making process. You will use knowledge, theories, and methods that you learned in this class to explain and address problems in the real world.

Academic integrity and collaboration: This is an individual assignment. You may discuss the assignments and approaches to solve the problems with your classmates, however, you may not share your written papers with them or provide them with the direct answers. See also: *Academic integrity policy*.

Details about each assignment, including guidelines and rubric, will be made available on Carmen Canvas.

Late submissions

By default, late submissions of discussion posts/responses, quizzes, assignments, final project (or paper) are subject to 5% grade reduction for each late day. Late submission is always better than no submission.

You have <u>one</u> opportunity to extend your deadline <u>for one day</u> during the semester (indicate it in your submission to get the full credit). This extension will be applied to an assignment of your choice (including the final project or paper). No permission is required; you will indicate in your submission that you are using the one-day extension. **We suggest that you use this opportunity wisely and reserve it for the end of the semester when the workload is unusually high.**

In case of personal and family emergencies, please notify me as soon as possible so that we can work out a new submission time. Such extensions will be granted on a case-by-case basis.

- **Writing style**: While there is no need to participate in class discussions as if you were writing a research paper, you should remember to write using good grammar, spelling, and punctuation. A more conversational tone is fine for non-academic topics.
- **Citing your sources**: When we have academic discussions, please cite your sources to back up what you say. For the textbook or other course materials, list at least the title and page numbers. For online sources, include a link.

- **Backing up your work**: Consider composing your academic posts in a word processor, where you can save your work, and then copying into the Carmen discussion.
- **Tone and civility**: Let's maintain a professional, supportive learning community where everyone feels safe and where people can disagree amicably. Criticize politely and constructively, focusing on the point being made, not the person who made that point.

Meaningful and constructive dialogue is encouraged in this class and requires a degree of mutual respect, willingness to listen, and tolerance of opposing points of view. Respect for individual differences and alternative viewpoints will be maintained at all times in this class through group meetings, online check-in's, and discussion/group activities. One's words and use of language should be temperate and within acceptable bounds of civility and decency.
