## **COURSE DESCRIPTION AND OBJECTIVES**

This course provides students with the opportunity to enhance and deepen their paid internship experience through reflections on their workplaces, their role in those workplaces, the relation between their coursework in Geography and their professional work experience, and the potential of their internship as a stepping-stone towards a career. This course is part of the suite of professionalization courses offered by the Geography department to help students move from the classroom to a career.

Although students do not meet in a classroom, they post weekly journal entries and several short, written assignments in the **Discussion** section of the Carmen course page so that they can read each other's entries and compare their experiences, with the option of replying to their peers and engaging in online discussion. In addition, students post other assignments in the **Assignment** section (see section on Written Assignments, beginning on p. 3).

This course aims to provide students the opportunity to reflect on and enhance the internship experience. Students will:

- identify your value system relative to career opportunities
- reflect on the relation between your expectations and workplace realities
- appraise options and trade-offs in career paths relative to your values
- identify the range of your skills relative to various career paths
- identify strengths and limitations of the range of your skills relative to various professional opportunities
- demonstrate your ability to learn new skills
- apply knowledge from formal training to examine problems
- use and integrate various skills learned from formal training
- integrate knowledges from formal training with those you have learned independently
- develop communication skills and professionalism, and navigate team environments
- employ teamwork to achieve results
- develop skill in communicating your credentials to potential employers
- recognize that workplaces have a code of conduct/ethics and how this code pertains to daily life in the workplace

# WRITTEN ASSIGNMENTS (see Assignments and Discussion tabs on course Carmen page)

Students complete weekly journal entries and short written assignments, and post them on Carmen. Responses should be complete and well written. *Guidelines for each assignment are on the course Carmen page in Modules*, which lists weekly instructions and assignments. Assignments will be marked 'no pass' if posted later than the due date, unless alternative arrangements are made with the instructor (*see late policy, p. 4*). All journal entries + the 1<sup>st</sup> assignment (Statement of Intent) are due on <u>Sundays</u> for the previous week; all <u>other</u> assignments are due on <u>Wednesdays</u>; you are welcome to submit before the due dates.

On the Carmen page in <u>Modules</u> (weekly schedule), when you click on an assignment, you will automatically be taken either to <u>Assignments</u> or <u>Discussions</u>, depending on where your assignment should be posted. **Pass/no pass grades on each assignment are posted on carmen.** 

Assignments include:

1) <u>Statement of Intent</u>, post in **Discussion** section of Carmen page (due by Wednesday, Jan 19): Students indicate basic information about themselves and their internship (1 paragraph); *see elaborated guidelines on the Carmen page in Modules.* 

2) Weekly Journal entries, due once each week, by Sunday midnight: Students post a journal entry once a week (at least 1 paragraph) in the Discussion section of the Carmen course page. Journal entries should capture students' general thoughts and reactions to their work experience for the preceding week. Notes regarding experiences relating to the learning objectives and connections to academic coursework will be helpful for reference when completing in Internship Final Report. Students post their first entry by the end of the 2<sup>nd</sup> week of their internship (see Weekly Schedule, pp. 5-6).

3) <u>Expectations and Reality</u>, post in **Discussion** section of Carmen page **(due by Wednesday, Feb 3):** Students indicate both their expectations for their internship, the nature of their work practices relative their expectations, and specify and reflect on the differences, if any, between their expectations and work realities (1 paragraph minimum); *see elaborated guidelines on the Carmen page in Modules.* 

4) <u>Workplace Code of Conduct or Ethics</u>, post in **Discussion** section of Carmen page **(due by Wednesday, Feb 16)**: Students ask their supervisor to share with them the Workplace Code of Conduct or Ethics, and summarize (do not repeat word for word) the main points. Then reflect on whether and the degree to which you have observed the code of ethics *in practice* in your experience in the workplace. (1 paragraph minimum)

5) <u>Interview</u>, post in **Discussions** section of Carmen page **(due by Wednesday, Mar 2)**: Students identify one person in an occupation/position they are interested in learning more about, schedule and complete the interview, and complete a written report that summarizes the experience and what they learned (minimum of two pages); *see elaborated guidelines on the Carmen page in Modules.* 

6) <u>Resume</u>, post in **Assignment** section of Carmen page (due by Wednesday, Mar 23): Students create and submit a professional resume, which normally is required when applying for full time employment opportunity or another internship; *see elaborated guidelines on the Carmen page in Modules* 

7) <u>Cover letter</u>, post in **Assignment** section of Carmen page **(due by Wednesday, Apr 6)**: Students write a hypothetical or actual cover letter for an application for a job; *see elaborated guidelines on the Carmen page in Modules* 

8) <u>Final Report, post in Assignment section of the Carmen page</u> (due by Wednesday, Apr 20): Students complete a final report that summarizes their work experience. The report should include an overview of significant work activities, a reflective evaluation of these experiences, and what you learned as well as connections to academic work (2 pages minimum); *see elaborated guidelines on the Carmen page in Modules.* 

9) <u>Verification Form</u> (*see link on Carmen page under Guidelines for Written Assignments +* Verification Form). This form is to be completed by the student at the end of the semester to document the completed work, then reviewed and verified by the student's supervisor. <u>The</u> <u>completed form is ungraded but required for course completion</u>. Completion and submission of this form by Wednesday, Apr 27 is <u>required to pass the course</u>.

<u>Late assignment policy</u>: The Assignment/Disscussion boxes <u>close</u> at the deadline. If you are pressed for time and cannot make a deadline, contact N. Ettlinger to reschedule the due date <u>before</u> the original deadline for the assignment.

**tip:** using a calendar (hard copy or online) is important to avoid missing assignments in the absence of face-to-face meetings. From past experience, *students who don't use a calendar miss assignments*!

### **Carmen Access**
