# **Course description**

Develops students' knowledge of world geography through the twin concepts of region and globalization; focuses on culture, society, politics, economy, and interplay between people and

environments.

## **LEGACY (pre-Autumn 2022) General Education Requirements**

If you started at OSU prior to Autumn 2022 and are completing your curriculum under what are known as the "legacy" GE requirements, this course meets two such requirements:

#### Social Science – Human, Natural, and Economic Resources

Goals: Students understand the systematic study of human behavior and cognition; the structure of human societies, cultures, and institutions; and the processes by which individuals, groups, and societies interact, communicate, and use human, natural, and economic resources.

#### Expected learning outcomes:

- a. Students understand the theories and methods of social scientific inquiry as they apply to the study of the use and distribution of human, natural, and economic resources and decisions and policies concerning such resources.
- b. Students understand the political, economic, and social trade-offs reflected in individual decisions and societal policymaking and enforcement and their similarities and differences across contexts.
- c. Students comprehend and assess the physical, social, economic, and political sustainability of individual and societal decisions with respect to resource use.

#### Students in GEOG 2750 will meet the above in in part by:

- i) learning about other peoples and cultures and geographic interactions between places at the regional and global scale in the context of globalization
- ii) exploring and reflecting on ways of understanding and learning about the world, including participation in data collection and out-of-class experiences
- iii)weighing pros and cons of diverse cultural approaches to major political, economic, and social issues and understanding them in diverse national contexts
- iv) applying a systems model of environmental change to the human role in environmental problems faced in different regions of the world

#### **Diversity – Global Studies**

Goals: Students understand the pluralistic nature of institutions, society, and culture in the United States and across the world in order to become educated, productive, and principled citizens.

## Expected learning outcomes:

- a. Students understand some of the political, economic, cultural, physical, social, and philosophical aspects of one or more of the world's nations, peoples and cultures outside the U.S.
- b. Students recognize the role of national and international diversity in shaping their own attitudes and values as global citizens

## Students in GEOG 2750 will meet the above in part by:

i) discussing and reflecting on the complex set of factors that motivate and inform decisions by people and governments in various regions

- ii) understanding the world through conceptualization of coherent regions and identification of political and cultural diversity between and within those regions
- iii) drawing comparisons and making contrasts between different places
- iv) placing themselves and their communities in the context of globalization and its impacts both here and abroad

# How your grade is calculated

Grades will depend upon four exams, seven map quizzes, and attendance. Exam 1 counts 15% of the course grade, Exams 2 and 3 count 15%, Exam 4 (Final) counts 25%, the Map Quizzes count 25%, and Attendance counts 5%. For planning purposes, there will be an exam at approximately every 2 weeks. The Map Quizzes cover each of they will precede the Exam on that region. A typical exam comprises 40 multiple choice questions. Each map quiz covers one of the regions and includes 15 items. I will provide a Map Quiz Study Guide on Carmen with 30-40 items. The dates of Exams are based on the previous time of offering the course and will be announced on Carmen.

Information will be shared only as necessary with investigators, witnesses, and the accused individual. *The Domestic Violence Shelter and the New Directions Student Assistance Program (SAP) staff are considered* 

confidential reporting resources. Every other faculty or staff member must notify the University of reports made.
