Course Description:

This course is an introduction to how urbanization occurs in various global settings. Cities have existed for thousands of years, and the unique geographical, social, political, and economic constraints lead to different urban forms. This course takes a chronological approach to urban development and then helps students develop a generalized theory of urbanization that can be combined with region-specific contexts.

Learning Outcomes:

- 1. Develop an understanding of why cities develop.
- 2. Identify the unique processes that lead to differing urban forms.
- 3. Analyze socio-geographic-economic-political factors that go into the making of a city.
- 4. Identify and understand various city types of the world.



5. Assess and understand global urban forms from a geographic, urban planning, and/or policy perspective, as well as potential future development patterns.

Lectures, Textbook, and Learning Technologies:

This is an in-person class with lectures. You are expected to attend the regular lectures and participate in class discussions.

Course textbook: No required textbook.

All readings and supplemental material will be posted on the Canvas course site.

You are responsible for ensuring access to the learning technology website and its tools. This includes seeking technical support from OSU staff when encountering any problems. Students must confirm that assignments have been successfully posted or files uploaded to Carmen to receive credit.

Grading:

Students will be evaluated based on their performance through three homework assignments, one take-home exam, one final project, and in-class participation and attendance.

Late Penalty:

Homework will be penalized 5% (of that homework's score) for every day late and will not be accepted after a week.

The final project will be penalized 10% for every day late and will not be accepted after three days.

Al Policy:

You may use AI services such as ChatGPT to explore and engage with ideas in this course. You can only do so in submitted assignments for homework and Final project. They may be used for pre-work: skimming through large quantities of data and obtaining relevant information to narrow down your ideas/arguments. However, once you have crystallized these ideas and selected your topic, you need to work on finding



data and information without Al generative work. You can NOT use Al for writing your paper or even sections of it. You can NOT use it as a source of information to back up your arguments. Your sources must come from non-Al publications. You may not use generative Al as a substitute for your own writing. You may not submit material created with generative Al as if it were your own work under any circumstance. Generative Al-assisted spell and grammar checks/plagiarism reviewers/citation generators are permissible- i.e., applications such as Grammarly are okay to use throughout the course. The use of Al generative services such as ChatGPT is NOT permitted for assignments other than the ones listed above and strictly not for exams or certifications. Al generative services must be limited to the abovementioned role for the homework and projects listed. If you have questions- please ask! Failure to comply with Al policy will result in an academic misconduct investigation.
